Hope you're doing well.

I am attaching a copy of the most recent amended license from California Deptment of Health, Rad Branch reflecting the name change from HIET Acquisition LLC to the current operating company Clear Path Technologies, Inc. for your records.

As you may recall we discussed this and I had explained that because of the budget issues in California there were extraordinary delays and I did not have it for you at the time of your follow up inquiry. You may also recall, we did make a similar request through your office with regard to a name change/transfer of the NRC license. We also provided supporting documentation to show the transition and the continuity of management, safety plan, etc. the receipt of which was confirmed in Jan 2010.

Having not heard from you I was hoping (and praying) our request had been accepted; however I have not received any notification. The matter is becoming a bit more pressing as we are looking to commence demonstrations including with the US Army.
