The purpose of this modification is to provide incremental funding in the amount of \$416,000.00 thereby increasing the obligated amount of the agreement from \$893,000.00 to \$1,309,000.00.

Accordingly, the following changes are hereby made:

- A. Subsection A.3, **Consideration and Obligation – Delivery Orders**, is deleted in its entirety and substituted with the following in lieu thereof:

"b" The amount presently obligated with respect to this contract delivery order is **\$1,309,000.00**. The Contracting Officer may issue orders for work up to the amount presently obligated. The obligated amount shall, at no time, exceed the order ceiling as specified in paragraph "a" above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."
