I am submitting the attached request for records that you may hopefully possess as per the "Illinois Freedom of Information Act (5ILCS 140/1)"

This request is in reference to an incident that occurred at the Byron Ill. nuclear plant during its construction, circa 1976-1978.


A human female skull was found, by a construction worker, at the Byron site during excavation procedures during that period. It is believed that this female skull could possibly be that of a homicide victim who was murdered in Oregon Ill. in 1948.

We ask for your help in locating and submitting to us any records that you may have in reference to this matter to assist in, an ongoing investigation, and to comply with a Federally mandated act, which is coordinated by the Illinois Historic Preservation Agency.

This Federal act mandates that a “provenance” be created pertinent to any skeletal remains held at the Illinois human skeletal remains repository. The human female skull captioned above is being held at this agency.

Any information or records that you could produce for us would be greatly appreciated, then copied and forwarded to the Illinois skeletal remains repository and the proper law enforcement agency.
