## ENTERGY'S OPPOSITION TO TOWN OF PLYMOUTH'S MOTION TO RESCHEDULE TELEPHONE CONFERENCE

Entergy Nuclear Generation Company and Entergy Nuclear Operations, Inc. (collectively "Entergy") oppose the Town of Plymouth, Massachusetts Motion to Reschedule Telephone Conference to Address Future Course of Proceeding (April 6, 2010). For the reasons discussed in Entergy's Opposition to Pilgrim Watch's Motion to Reschedule Telephone Conference (April 7, 2010), delaying the conference call and the scheduling of the remanded proceeding by a month is both inconsistent with Commission policy and injurious to Entergy.
