
The purpose of this modification is to provide incremental funding in the amount of \$70,000.00, thereby, increasing the obligated amount from \$220,000.00 to \$290,000.00. Accordingly, the delivery order is hereby modified as follows:

Under Section A.2, CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988), Paragraph (b), Sentence 1, is deleted in its entirety and replaced with the following:

"(b) The amount presently obligated with respect to this contract is \$290,000.00."

All other terms and conditions of this delivery order remain the same, including the ceiling amount of \$985,000.00 and the period of performance expiration on 12/16/2013.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
