Mookhoek, etc) regarding the staff's detailed review of the STP Units 3 and 4 COL Application. The purpose of the call was to clarify the request for addition information (RAI) on technical topics in accordance with Standard Review Plan Chapter 2.5. RAIs will be issued based on this call. However the applicant has agreed to a public meeting to resolve some of the technical issues.
