Dear Administrative Judges:

In its Order dated January 8, 2009, the Atomic Safety and Licensing Board ("Board") directed the NRC staff ("Staff"), commencing on January 15, 2009, to tender each month "a short report advising as to whether the estimated dates for issuance of the final [Safety Evaluation Report ('SER')] (predicted for summer/fall of 2009) and final [environmental review document] (predicted for December of 2009) have changed or become more definitive." The Staff estimates that it will issue the final environmental review document by June 2010. The Staff expects to issue the SER by September 2010.

In keeping with the Board's mandate, the Staff will tender its next monthly status report by May 14, 2010.
