Dear Mr. Galdes:

Enclosed is Amendment No. 07 to your NRC Material License No. 21-26580-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

In your letter dated February 17, 2010, you indicated that you wished to remove for unrestricted use the former storage locations at 1601 Portage Street, Kalamazoo, Michigan and 70 East 91<sup>st</sup> Street, Suite 100, Indianapolis, Indiana.

The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from your former storage locations and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for these storage locations and are suitable for unrestricted use.

As a reminder, an NRC-approved license amendment is required before receiving, using, and storing licensed material at an address or location not included with the application or already listed on the license.

Please note that License Condition No. 13.F. has been added to your license specifying that leak test records must be kept in units of microcuries and maintained for three years.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.
