03/25/2010 Conversation w/Linda Ramirez

I spoke with Linda Ramirez, consultant, point of contact, informing her that we would need a preceptor attestation and NRC Form 313A (RSO) to be completed and submitted for us to continue our review of this request. We discussed the different sections of the forms that needed to be completed.

She agreed with the request.

04/01/2010 Conversation w/Linda Ramirez and Frank Bloe (consultant)

I spoke with Linda Ramirez to discuss status of response and she indicated that she probably would not be able to use the out-going RSO, Dr. Slaven, as the preceptor and if Frank Bloe, consultant and RSO for Oklahoma license authorized for equivalent 35.200 materials. I informed her that I would have to discuss with another reviewer.

NOTE: I discussed the preceptor option above with Toye Simmons and she agreed that I it could be done in that manner.

04/01/2010 Conversation w/Linda Ramirez

I informed Linda that Frank Bloe can be the preceptor as long as he is named as an RSO with at least equivalent authorizations he is attesting for Dr. Gonzales.

Linda informed me that the response should be sent by 04/15/2010, but more than likely sent sooner. → FYI.....response letter dated 04/01/2010 was received via email on 04/05/2010; note, initial attempt to submit response was via facsimile on 04/02/2010 but was not entirely received, therefore, licensee sent scanned response in its entirety via email on 04/05/2010.
