The purpose of this modification is to obligate FY'10 funds in the amount of \$6,858.00, thereby increasing the obligated amount of the subject task order from \$164,743.00 to \$171,601.00.

Accordingly, the following changes are hereby made:

The third and fourth paragraphs of the definitization letter dated, September 30, 2005, are deleted in their entirety and substituted in lieu thereof the following:

"Task Order No. 1 shall be in effect from June 22, 2005, through June, 21, 2010, with a cost ceiling of \$171,601.00. The amount of \$157,432.00, represents the total estimated reimbursable costs, and the amount of \$14,169.00 represents the fixed fee.

The amount presently obligated with respect to this task order is \$171,601.00, of which the amount of \$157,432.00 represents the reimbursable cost, and the amount of \$14,169.00 represents the fixed fee."
