The purpose of this letter is to provide a schedule for submittal of the Calvert Cliffs Nuclear Power Plant (CCNPP) Unit 3 guidance and strategies for Loss of Large Areas (LOLA). The LOLA guidance and strategies are required for compliance with 10 CFR 50.54(hh)(2) and 10 CFR 52.80(d). UniStar Nuclear Energy is developing the guidance and strategies utilizing the Nuclear Energy Institute (NEI) template document NEI 06-12 (Reference 1) and NRC Interim Staff Guidance ISG-016 (Reference 2). The LOLA guidance and strategies will be provided as a supplement to the CCNPP Unit 3 Combined License Application, Part 8, Security Plan, and will be submitted to the NRC by June 30, 2010.
