To whom it may concern:

In a recent conversation with Michael Reichard, he advised that we apply for an amended license to increase the total number of portable nuclear density gauges permitted to four (4). Our current license only permits one (1) gauge.

In particular, the following amendments are requested:

1. Under Section 8 (Maximum Amount That Licensee May Possess At Any One Time Under This License), of the license, the millicurie totals will need to be increased by a factor of four (4). As such, Cesium 137 (Item 8A) will increase to 36 millicuries total and Americium 241 (Item 8B) will increase to 176 millicuries total.
2. Under Section 9 (Authorized Use) we request that the text be modified to specify that no more than a combination of four (4) Troxler Electronic Laboratories Models 3430 and 3440 portable gauging devices for measuring physical properties of materials will be permitted under the license.
3. No other aspects of the license are changing. Storage facility location is unchanged and is adequate in size and security for the number of gauges requested.
