Dear Mrs. Gaskins:

This letter serves to provide the additional information that you have requested for a license amendment to the Connecticut Heart Group, PC.

A. Mr. Peter Mas, MS, our consultant-RSO, is delegated the authority over the radiation safety program in order to remedy any safety problem that may arise. The management of our practice is in agreement on the delegation of authority for that purpose.

B. Our consultant may recommend the expenditure of funds in order to achieve the objectives of our radiation safety program. Our program has been in operation for several years and, at the present time, there are no facility or equipment upgrades pending.

C. We are aware that our consultant is the full time medical health physicist for Hartford Hospital. Mr. Mas has been provided key and alarm code access to our offices in order to conduct his reviews of the operations at anytime. It is expected that he will review each site every calendar quarter period and spend approximately 1 to 1.5 hr at the sites.

D. We are appointing Mrs. Dawn Coons, CNMT, as our point of contact during the RSO's absence. She may assist the RSO with limited authority.


