The inspection was limited to observations by the inspector, interviews with personnel, selective examination of records, and confirmatory surveys of burial pit #3. Additional information was provided on February 4, February 23, and March 23, 2010 and was examined as part of the inspection. The findings of the inspection were discussed separately with you and Michael Winters of Shaw Group at the conclusion of the inspection. The enclosed report presents the results of this inspection.
