

The purpose of this modification is to provide incremental funds in the amount of \$250,448.00, thereby increasing the total obligations from \$639,000.00 to \$889,448.00. Accordingly the contract is modified as follows:

Refer to Section B.4 "Consideration and Obligation -- Cost Reimbursement (Jun 1988)" paragraph (b) is deleted in its entirety and replaced with the following:
"(b) The amount obligated by the Government with respect to this contract is \$889,448.00"

All other terms and conditions remain unchanged including the contract ceiling of \$977,386.00.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
