Mini-Seminar on “Safety Demonstration Framework for Digital Instrumentation & Control Systems”

On April 7, 2010, RES staff hosted a mini-seminar on “Safety Demonstration Framework for Digital Instrumentation & Control Systems,” led by John Knight, Professor of Computer Science at the University of Virginia. Participants included technical staff from the Offices of Nuclear Reactor Regulation, New Reactors, and RES. Although the primary purpose of Knowledge Management was served well, the seminar also yielded insights into regulatory research needed in this area.

Publication of Regulatory Guide (RG) 1.68.2, Revision 2, “Initial Startup Test Program to Demonstrate Remote Shutdown Capability for Water-Cooled Nuclear Power Plants.”

On April 14, 2010, RES staff published an RG that describes an initial startup test program acceptable to the NRC staff for demonstrating hot shutdown capability and the potential for cold shutdown from outside the control room. Publication of RG 1.65, Revision 1, “Materials and Inspections for Reactor Vessel Closure Studs.”

On April 14, 2010, RES staff published an RG that provides guidance for use in selecting reactor vessel closure stud bolting materials and properties, conducting a preservice inspection, and conducting an in-service inspection. Publication of RG 6.9, Revision 1, “Establishing Quality Assurance Programs for the Manufacture and Distribution of Sealed Sources and Devices Containing Byproduct Material.”

On April 14, 2010, RES staff published an RG that directs the reader to the type of quality assurance and quality control program acceptable to the NRC staff during the review of an application to manufacture or distribute sealed sources and devices containing byproduct materials. Publication of Draft Regulatory Guide 4018 (DG-4018) “Constraint on Releases of Airborne Radioactive Materials to the Environment for Licensees other than Power Reactors.”

On April 14, 2010, RES staff issued DG-4018 to provide an opportunity for public comments. The draft guide is proposed Revision 1 to RG 4.20 that provides guidance on methods acceptable to the NRC staff for meeting the constraint on air emissions of radioactive material to the environment as described in Title 10, Section 20.1101(d), of the *Code of Federal Regulations* (10 CFR 20.1101(d)).
