Dear Mr. Reichhold:

As you have been informed by our counsel, Valerie Reich, Gerber Memorial Health Services ("GMHS") and Spectrum Health System ("Spectrum") are entering into a transaction in which Spectrum became the sole corporate member of GMHS. We anticipate this transaction will be effective May 1, 2010.

As the sole corporate member, Spectrum will have certain reserved powers and will replace the current members of GMHS in overseeing the governance and management of GMHS. Top tier management of GMHS will not change as a result of the transaction, however, the Chief Executive Officer and Chief Financial Officer of GMHS will report directly to Spectrum. Per correspondence with Larry Horvath of the Michigan Department of Community Health, the transaction does not constitute a change of ownership or require a CON under Michigan law because the corporate entity, corporate identification number, and/or tax identification number will not change as a result of the transaction. Therefore, GMHS' hospital license will not be affected.

GMHS will retain control over the licensed activities, *i.e.*, when and how the licensed will be used, as the authority over the license will not change as a result of the transaction.
