Recently an audit of your documents for providing financial assurance for decommissioning for Nuclear Regulatory Commission License No. 19-11831-03 was performed. In order to correct the below deficiency, we need the following additional document.

Please submit a new Certification of Financial Assurance document. The current one dated July 31, 2008, does not have the total activity for Co-60 material listed accurately. The additional limiting condition #12.B. needs to be listed on your Certification of Financial Assurance document to limit the materials authorized in your Broad Scope B authorization.
