1. In accordance with Contract Clause C.6 Option to Extend the Term of the Contract (MAR 2000), Option Year Three is hereby exercised. The period of performance for Option Year Three is May 2, 2010 through May 1, 2011.

2. Contract Clause B.4 is hereby revised as follows:

"This contract shall commence on August 2, 2007 and will expire on **May 1, 2011**. The term of this contract may be extended at the option of the Government for an additional **one year**."
