


LICENSEE: The inspection was an examination of the activities conducted under your license as they relate to radiation safety and to compliance with the Nuclear Regulatory Commission (NRC) rules and regulations, and the conditions of your license. The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector. The inspection findings are as follows:

This form is a NOTICE OF VIOLATION, which may be subject to posting in accordance with 10 CFR 19.11. 10 CFR 32.16(a) and (b) requires, in part, that each person licensed under Part 32.14 shall maintain records of transfer of material and file a report with the Director, FSME, which includes the identification of the specific licensee and license number of the licensee making the report, the statement that the products transferred are for use under Part 30.15 of this Chapter, description of the product, quantity of radionuclide for each product, and the number of units of each product. 10 CFR 32.16(c)(1) requires, in part, that the licensee shall file this report, covering the preceding calendar year, on or before January 31 of each year. In its first report after December 17, 2007, the licensee shall separately include data for transfers in prior years not previously reported to the Commission. Contrary to the above, the licensee failed to file a summary report with the NRC including the above information by January 31 of each calendar year, for licensed material transferred during calendar years 2006 through 2009. These reports were filed by email on April 21, 2010, as corrective actions for this violation.			
Licensee's Statement of Corrective Actions for Item 4, above.			
I hereby state that, within 30 days, the actions described by me to the inspector will be taken to correct the violations identified. This statement of corrective actions is made in accordance with the requirements of 10 CFR 2.201 (corrective steps already taken, corrective steps which will be taken, date when full compliance will be achieved).
