I want to thank the individuals and Program Offices for their support yesterday evening thru this morning to track and coordinate the event and stakeholder interfaces associated with the TMI containment radiation release. As of this morning at 2 a.m. we had completed internal briefings (including a Commission T.A. brief) and licensee updates. The TMI resident inspector (Javier Brand) is onsite and the DRS Team of John White and Ron Nimitz are enroute. Diane Screnci (Sr. PAO for Region I) has been coordinating with the Exelon Spokesperson who has a press briefing scheduled for this morning. Diane intends to conduct a NRC led briefing this afternoon following our Sunday morning onsite reviews. Nancy McNamara has been coordinating with the Commonwealth of PA for their involvement in the briefing. I also want to acknowledge the professional duties of the HOO during the event followup...More to follow as review the source of the release and confirm the site analysis of individual contamination and release outside containment.
