On April 22, 2010, the U.S. Nuclear Regulatory Commission (NRC) held a public meeting at the Two Creeks Town Hall in Two Creeks, Wisconsin. The meeting was between NRC representatives and FPL Energy Point Beach, LLC, representatives to discuss the NRC's 2009 End-of-Cycle Assessment of the Point Beach Nuclear Plant's safety performance. The results of that assessment were discussed in a letter to the licensee dated March 3, 2010, (ADAMS ML100610484).

The NRC began the meeting with an overview of the NRC, the NRC's Reactor Oversight Process (ROP), National ROP results, and the Action Matrix. This was followed by a summary of the NRC's assessment of Point Beach performance in 2009.
