Dear Dr. Sear:

This refers to the letter dated January 27, 2010, notifying the NRC of the transfer ownership and control of the NRC License No. 24-32245-01 issued to Kansas City Cardiology Associates, Inc. Based on the information submitted, the NRC consents to the transfer as described. Enclosed is Amendment No. 14 to your NRC Material License No. 24-32245-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

In correspondences dated January 7, 2010, April 7, 2010, and April 9, 2010, you indicated that you wished to release for unrestricted use the location at 6420 Prospect Avenue, Suite T-509, Kansas City, Missouri. The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from your former use location and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this use location and it is suitable for unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.
