

The purpose of this modification is to provide incremental funding in the amount of \$51,855, which increases the task order obligated amount from \$60,855 to \$112,710.

Accordingly, the following change is hereby made:

1. Section A CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988), Paragraph (c) is hereby deleted in its entirety and replaced with the following:

- (c) The amount presently obligated with respect to this order is \$112,710, of which the sum of \$ [REDACTED] represents the estimated reimbursable costs, and of which \$ [REDACTED] represent the fixed fee.
