

The purpose of this modification is to provide incremental funding in the amount of \$61,076, which increases the task order obligated amount from \$86,913 to \$147,989.

Accordingly, the following change is hereby made:

1. Section A CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988), Paragraph (c) is hereby deleted in its entirety and replaced with the following:

- (c) The amount presently obligated with respect to this order is \$147,989, of which the sum of \$ [REDACTED] represents the estimated reimbursable costs, and of which \$ [REDACTED] represent the fixed fee. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

A summary of obligations under this order, from date of award through this modification, is given below:

FY'10 obligation amount: \$147,989

Cumulative total of NRC obligations to date: \$147,989

This modification obligates \$61,076 in FY'10 funds

All other terms and conditions of this task order remain unchanged.
