Steve,

I assume that the NRC staff is still working on preparing notes for the 4/20/10 public conference call. I believe that Mr. Forte of BRA made some key points regarding the site known as South Bend Reservoir during this call. I am passing these on to you for your consideration as you draft the meeting notes.

- At this point in time, the South Bend Reservoir site does not exist and is not contemplated in either the current 2006-07 water plans or the draft of the 2011-12 water plans.
- The concept of South Bend Reservoir, along with another half-dozen or so other non-existing Brazos River main-stem (and tributary) reservoirs, is a remnant of planning from back in the late 40's and early 50's.
- Of the 6 to 10 sites identified back then, only three have been built.
- There have been no site-specific studies for South Bend Reservoir (including engineering, land surveys, or any other assessments or analyses) by BRA, and none is contemplated in the near-term financial or water supply planning.
- The State Water planning process in Texas is dynamic, and renewed every five years, based on any number of variables (population estimates, actual water consumption, climate change, etc.) and looks ahead through the year 2060. No plans have been developed beyond 2060. The South Bend Reservoir is not included in the plans out to 2060.
