ORDER

(Concerning Scheduling)

On April 20, 2010, the Board was established to conduct a mandatory hearing in this proceeding.

Pursuant to 10 C.F.R. § 2.332(d) and the applicable Notice of Hearing and Commission Order, see 75 Fed. Reg. 1819 (Jan. 13, 2010), the Board must consider the NRC Staff's projected schedule for completion of its safety and environmental evaluations in developing a hearing schedule. Accordingly, on or before June 1, 2010, the NRC Staff shall inform the Board of its best good-faith estimates of the Staff's projected schedule for issuing its final environmental impact statement (FEIS) and safety evaluation report (SER). Should either estimate materially change, the Staff shall promptly submit a revised estimate or estimates, as appropriate.

At present, the Board expects to conduct an initial scheduling and case management conference, by telephone, on August 19, 2010, at 10:00am Eastern daylight time. Confirmation

of the date and time of the conference and details concerning that conference, including an agenda, will be provided in a subsequent order.
