This situation should have been straightforward, as we have had such changes in the past.

In this case, the owner of the existing license at this site, Dr. Adem, is not administratively or financially involved in the practice. The existing licensee does not own the facility or the equipment. He does not supervise the facility.


The original request was to simply delete Dr. Adem as the owner at the location under his license, and add the new owners as the licensee. Your office requested a new license application, submitted by the new owners, which has been submitted.

Clearly, there cannot be two (2) licenses at the same location. Clearly, that was never the intent or the request. Your paperwork attests that with the issuing of the new license, the old license for this location is void and all parties have agreed, in writing, to that effect.


As the representative for this site, I am concerned that the existence of a license, currently, does not affirm the existence of a licensee RSO, etc., as required under the license. The site has no authority until the NRC transaction is complete.

In summary, this is a change in ownership of a licensed facility and a transfer of that ownership to the new owners.
