9. As a reminder, CFR 20 requires that all individuals who are occupationally exposed to radiation be given an annual report of the yearly exposures.
10. Worker instruction is due this month for all nuclear medicine personnel.
11. The Co-57 sheet source for daily uniformity testing is nearing the end of its effective half-life. Please have a replacement ordered in the near future. **When ordering a new Co-57 source, please be sure to check-out the returning flood as a radioactive package, and check-in your new flood as a radioactive package on your package receipt forms. Also, be sure to obtain confirmation from the company your source is returned to that they have received the flood.**
12. Your Radiation Protection Program, under Rules for the Safe Use of Radiopharmaceuticals, states "Do not eat, or drink in any restricted area". Contrary to this, food and drink was in the nuclear medicine room during my visit. The technologist was told this is not allowed.
13. As a reminder, 10 CFR 20.1101(c) requires each licensee to periodically (at least annually) review the Radiation Protection Program content and implementation. Please use the enclosed template for this annual review due in May.

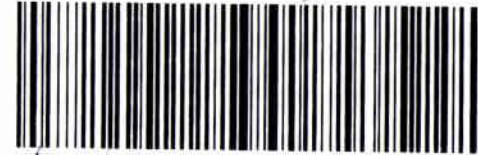
