In reviewing the information provided in Reference (b), the Nuclear Regulatory Commission has requested an additional file related to the submitted information. The requested file is attached [Attachment (1)].

This supplemental information does not change the environmental assessment provided in Reference (a) and the categorical exclusion set forth in 10 CFR 51.22(c)(11) is still valid.
