The purpose of this modification is to provide incremental funding in the amount of \$183,825.84, thereby increasing the obligated amount from \$285,000.00 to \$468,825.84.

Accordingly, the following is hereby revised:

1. Section A.2 – “Consideration and Obligation – Labor Hours,” paragraph (b) is revised to read as follows:

“(b) The amount presently obligated with respect to this contract is \$468,825.84. This obligated amount maybe unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling (\$468,825.84) as specified in the paragraph above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligate amount, The Contractor shall be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor’s sole risk.
