The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contract's effective period; provided, that the Contractor shall not be required to make any deliveries under this contract after 6 months the contract period of performance.

- (c) The contractor shall insert this or the substance of this clause in any subcontracts involving work performed under this contract.
