The purpose this modification is to add additional tasks, increase the ceiling the ceiling of this task order and provide incremental funding to cover the additional tasks. First, funding in the amount of \$1,400,000.00 shall be added to this task order increasing the NRC obligation from \$973,765.00 to \$2,373,765.00. Next, the ceiling of this task order will also increase by \$2,151,000.00 from \$1,012,800.00 to \$3,163,800.00. Finally, the additional work to be accomplished under task order 3 is defined in the revised Statement of Work (SOW), see attachment 1. 1. Background

NRC's Agencywide Documents Access and Management System (ADAMS) was developed using the FileNET™ suite of products (Commercial Off-the-Shelf package), integrated with the ForeMost™ records management product to provide both document management and record management functionalities required by the agency.

2. Objective

Beginning in 3rd Quarter of 2007 the number of Combined Operating License Applications (COLA) for construction of new nuclear power plants and license renewal applications for existing power plants has continually increased. At the same time the License Application for the Yucca Mountain High Level waste repository has been docketed by the NRC. ADAMS, which is an aged platform, is the center to the effective processing of all the licensing and re-licensing activities. To support the agency's document management and content discovery requirements, there is an urgent and continuous need for some customizations of ADAMS for an incremental and phased migration to the new version of the IBM® FileNet® P8 software product (P8). This Task Order will address some of the most pressing tasks and the required customizations and migrations of ADAMS to the P8 environment.

2.1 ADAMS Overview

NRC ADAMS (Agencywide Documents Access and Management System) is a customized Document Management System, with a FileNET™ Integrated Document Management (IDM) foundation. It is comprised of a Distributed IDM Document Services (IDMDS) System with two WAN Nodes, Headquarters and Public. One-way replication is enabled across a firewall that separates the -two nodes; three internally accessible Headquarters Libraries replicate to two Public Libraries, which are externally accessed via the Internet by means of Citrix MetaFrame or by Convera's RetrievalWare (web-based) product. The above mentioned ADAMS software components will be replaced by newer versions of the software that is collectively called P8.

3. TYPE OF TASK ORDER

This is a time and materials task order.

4. CONSIDERATION AND OBLIGATION CLAUSE

- (a) The total estimated amount (ceiling) for the products/services ordered, delivered, and accepted under this task order is **\$2,373,765.00 (including not to exceed travel amount of \$4,000.00)**.
- (b) The amount presently obligated with respect to this task order is **\$2,373,765.00**. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount

if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

5. Scope of Work

The Contractor shall provide customization and integration support in extension of what is covered under the Annual Licensing Agreement. The scope includes extension of the functionality of the ADAMS through customization of the existing FileNET™/ADAMS Platform and Libraries for synchronized and parallel migration ensuring the continuity of the mission of the Agency throughout the IBM® FileNet® P8 transition, and support of the new expansions as articulated below:
