We have reviewed your letter dated December 31, 2009, requesting an amendment to your byproduct materials license. We find that we need additional information as follows:

1. **In your letter dated December 31, 2009, you requested to remove the storage location in St. Peters, Missouri from your byproduct materials license, however you did not provide the leak test results for the licensed gauges stored in this location. Please submit the leak test result conducted prior to the transfer of the licensed gauges.**

We will be unable to continue processing your request until we receive this information.
