Dear Mr. Hackman:

This refers to your NRC license listed above. The latest amendment to your license (Amendment No. 03) does not include maximum possession limits for the radioisotopes authorized on the license. Current NRC policy requires that a license include a maximum possession limit for each radioisotope authorized on the license. Therefore, we have administratively amended your license to incorporate this requirement and Item 8 of the license is revised to include maximum possession limits for the radioisotopes authorized on the license. These limits are based on the information provided by Rohan Perch of your staff on May 13, 2010, during my telephone discussion with him. Additionally, Condition 13 that appears in the previous amendment to your license is removed because it is no longer needed, and Condition 19 that appears in the previous amendment is also removed because it is not applicable to the type of gauges authorized on your license. Conditions are renumbered accordingly in the amended license. Enclosed with this letter is the amended license.

You must request and receive an amendment to your license prior to acquiring licensed material in excess of the limits specified in Item 8 of the license..

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
