Purchase Order NRC-DR-10-08-396 is hereby modified as follows:

1. The period of performance of the order is hereby extended to August 19, 2010. The authority to extend the order is FAR clause 52.217-8 Option to Extend Services. All unit prices shall remain unchanged for this extension. Per an e-mail, dated May 5, 2010, Chesapeake Security Co. has waived the requirement for bilateral signature.
2. Section A.9 – 52.216-18 Ordering – Part (a) of the order is hereby revised as follows:

“Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from June 20, 2008 through August 19, 2010.”
