Again my apologies for not responding to your April 1 letter sooner. Some additional information is needed, however:

1. The attachments to this letter were copies of the financial assurance documents. We need the original documents with the actual signatures. Please submit the actual Surety bond (originally signed duplicate) and associated documents.
2. the Certification of Financial Assurance (CFA) lists only the Mn-54, Co-60 and Zn-65 shown on your license. The CFA also needs to list the Items 6/7/8 B "Any byproduct materials with atomic numbers 1 through 83, 30 millicuries per radionuclide and 1 curie total" Please submit a revised, original CFA.
3. In accordance with the guidance in NUREG-17547, Volume 3, Appendix A.9 "surety Bonds", please submit
  - a) a copy of the broker/agent's power of attorney authorizing the broker/agent to issue bonds on behalf of the issuing company, and
  - b) documentation that you have established the Standby Trust Fund, as described in Appendix A.17. "Standby Trust Funds"
