Desc: Seeking records of the following, including but not limited to information about the Dineh Navajo tribe (tribal people) as follows:

1. Any records in any format involving the American Indian people known as the Dineh, also known as the Dine-Navajo, from 1960 to the present day. Please include any involving them with Peabody Western Coal Company a/k/a Peabody Group, the Mojave Generating Station, and the Navajo Generating Station.
2. Any records in any format involving Nuclear Waste or other Environmentally Hazardous such spills in Church Rock, New Mexico.
3. Any information about the use of Uranium Ore from the United Uranium mining of the Church Rock Mines.
4. Any information about the relocation of Dine Navajo through the Navajo Resettlement Act 1974 (PL 93-531) as amended and since, particularly the bands relocated to the above referenced Church Rock, New Mexico.

5. Any information regarding the underground Coal Slurry Pipelines that proceed from Kayenta and the Black Mesa mining territories and any blasting of Coal in the Black Mesa of Arizona on formerly Dine Navajo Territories.

6. Any information pertaining to the above not specified, including but not limited employment of Dineh Navajo in Uranium Mining, mortality among Navajo in Uranium Mining, and any other interaction between the US Government and the Navajo.

The purposes for this request, which is simultaneously being issued to the NRC, the EPA and the BIA, is for the Public Interest in the impact of these programs on the estimated 289,000 members of the Dineh Navajo tribe(s), and the Human Rights Commissions investigation of these activities, its outcome, the payment of restitution and the restoring of the Dineh to their Lands and the repair of their damages thereof.

As a Charitable, Volunteerist Foundation, the American Computer Science Association Inc. claims hardship and requests that all duplication fees be waived and that these records be secured on an expedited basis.

Public Interest has responded positively and unanimously to our obtaining these records and incorporating them into the Public Record.
