

The purpose of this modification is (1) to increase the level of effort of the task order by 612 hours from 1,334 hours to 1,946 hours, (2) increase the total task order ceiling by \$81,443, from \$163,988 to \$245,431, and (3) to provide incremental funding in the amount of \$81,443, which increases the task order obligated amount from \$163,988 to \$245,431.

Accordingly, the following change is hereby made:

1. Section A CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988), Paragraphs (a) and (c) are hereby deleted in their entirety and replaced with the following:

(a) The total estimated cost to the Government for full performance of this contract is **\$245,431**, of which the sum of [REDACTED] represents the estimated reimbursable costs, and of which [REDACTED] represents the fixed fee

(c) The amount currently obligated by the Government with respect to this contract is **\$245,431**, of which the sum of [REDACTED] represents the estimated reimbursable costs, and of which [REDACTED] represents the fixed fee.
