SUBJECT: TERMINATION OF YOUR NRC RADIOACTIVE MATERIALS LICENSE

On NRC Form 314 dated July 1, 2009, you informed the U.S. Nuclear Regulatory Commission that you wished to terminate NRC License No. 53-29233-01. The supporting documentation provided stated that all radioactive material possessed under this license had been transferred to a licensed entity and that their corresponding leak test results indicated that there was no leakage of radioactive material from the sealed sources. Based on this information and a review of your historical file, the staff concluded that all licensable radioactive material has been removed from your facility. Your facility located at 707 Kakoi Street, Honolulu, Hawaii, is suitable for unrestricted use in accordance with 10 CFR 20.1402, "Radiological Criteria for Unrestricted Use." No further remediation or actions with respect to NRC regulated material is required. Therefore, NRC License No. 53-29233-01 is hereby terminated as stated in the enclosed Amendment No. 02 to the license. An environmental assessment for this licensing action is not required since this action is categorically excluded under 10 CFR 51.22(c)(20)(ii).
