<u>General Comment, Part 8, Physical Security Plan, Section 2, Performance Objectives</u> (Page 2), and Section 17, Review, Evaluation and Audit of the Physical Security Program (Page 25): Describe how the requirements of 10 CFR 73.58 for managing safety/security interface will be met. Provide descriptions in the FSAR (i.e., Part 2) that describe of how plant management controls and process will be applied to meet 10 CFR 73.58 to manage the safety/security for the VC Summer Units 2 and 3.

VCSNS RESPONSE:

The management controls and processes used to establish and maintain an effective interface between nuclear safety and physical security, as required by 10 CFR 73.58, "Safety / security interface requirements for nuclear power reactors," are met through the application of administrative procedures. These controls and processes assess changes to plant configurations, facility conditions, or security prior to implementation for potential adverse impacts to nuclear safety or physical security, including the station emergency plan. FSAR Subsection 13.5.1 will be revised to include the safety/security interface implementation process in the list of procedural instructions provided in plant administrative procedures.

A future revision of the COLA will reflect the changes discussed in this response.

COLA Part 2, FSAR, Subsection 13.5.1, Administrative Procedures, 7th paragraph, will be revised by adding new bulleted text at the end of the current set of bullets, to read:

A process for implementing the safety/security interface requirements of 10 CFR 73.58
