

The purpose of this modification is to (1) exercise Option Year 1 of the contract, thereby extending the period of performance of the contract from May 31, 2010 to May 31, 2011 (2) increase the ceiling amount of the contract by \$28,046.64 from \$26,711.04 to \$54,757.68 (3) increase the amount obligated by \$28,046.64 from \$26,711.04 to \$54,757.68. Accordingly, the contract is modified as follows:

(1) Refer to Section B.3 entitled, "CONSIDERATION AND OBLIGATION – FIRM FIXED PRICE (JUNE 1988)", first sentence is deleted in its entirety and substituted with the following in lieu thereof:

"The firm fixed price of this contract is \$54,757.68"

(2) References made to the period of performance are revised as follows:

"This contract shall commence on June 1, 2009 and will expire on May 31, 2011. The term of this contract may be extended at the option of the Government for an additional 3 1-year options."

A summary of obligations from the date of award through the date of this action is provided as follows:

This modification obligates FY10 funds in the amount of \$28,046.64.
