The purpose of this modification is to (1) extend the period of performance from February 17, 2010 through March 18, 2010, (2) increase the contract ceiling amount by \$1,400.00 from \$137,591.80 to \$138,991.80 and (3) provide incremental funding in the amount of \$1,400.00 thereby increasing the total obligations from \$106,237.68 to \$107,637.68. Accordingly the contract is modified as follows:

(1) Refer to section B.5, "DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988)" the first paragraph is deleted in its entirety and replaced with the following in lieu thereof:

"The ordering period for this contract shall commence on February 17, 2010 and will expire on March 18, 2010. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.)"

(2) Refer to section B.4, "CONSIDERATION AND OBLIGATION - DELIVERY ORDERS (JUNE 1988)" paragraphs (a) and (b) first sentence are deleted in there entirety and replaced with the following in lieu thereof:

"(a) The total estimated amount of the contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$138,991.80.

(b) The amount presently obligated with respect to this contract is \$107,637.68."
