SUBJECT: VIRGIL C. SUMMER NUCLEAR STATION UNITS 2 AND 3 –
COMBINED LICENSE APPLICATION – ADVANCED SAFETY
EVALUATION WITHOUT OPEN ITEMS FOR CHAPTER 8,
“ELECTRIC POWER”

By letter dated March 27, 2008 (ML081300460), South Carolina Electric & Gas (SCE&G) submitted an application to the U.S. Nuclear Regulatory Commission (NRC) for a combined license (COL) application for Virgil C. Summer Nuclear Station (VCSNS) Units 2 and 3.

Based on our review of the application, the staff is providing the Advisory Committee on Reactor Safeguards (ACRS) its Advanced Safety Evaluation (ASE), without open items for Chapter 8, “Electric Power” (ML102370262). Unless otherwise stated in the ASE, the staff’s review was based on Revision 2 of the application. The ASE is being provided to support a meeting of the subcommittee of the ACRS scheduled to be held in December 2010. The ACRS Full Committee meeting will be held after the subcommittee meeting.

The staff has reviewed the ASE and found no topics that meet the categories of interest that ACRS members would like to review in detail.
