The purpose of this modification is to extend the task order performance period to 01/18/10 at no additional cost to the Government. Accordingly, the subject task order is hereby modified as follows:

Paragraph 3, page 2 of 2 under the base task order 01, is hereby deleted in its entirety and replaced with the following:

“Task Order No. 009 shall be effective from June 15, 2009 through January 18, 2010, with a task order ceiling of \$1,284,666.18. The amount of \$1,220,751.43 represents the estimated reimbursable costs, and the amount of \$63,914.75 represents the fixed fee.”
