Dear Mr. Schwarz:

On May 10, 2010, the U. S. Nuclear Regulatory Commission (NRC) completed an inspection at your Palisades Nuclear Plant. The inspection covered the transition from a contract to a proprietary security force. The enclosed inspection report documents the inspection results, which were discussed on May 11, 2010, with Mr. D. Hamilton and other members of your staff.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspector reviewed selected procedures and records, observed activities, and interviewed personnel.

No findings of significance were identified.
