The purpose of this modification is to:

1. Provide funding in the amount of \$300,000.00, thereby increasing the obligated amount under the contract from \$4,207,296.79 to **\$4,507,296.79**.
2. Correct a typographical error in the ending date of the period of performance reflected in previous Modification No. 11.

Accordingly, the following changes are hereby made to the order:

1. Under section A.2 CONSIDERATION AND OBLIGATION – DELIVERY ORDERS (JUN 1988), the first sentence of paragraph (b) is revised to read as follows:

“(b) The amount currently obligated by the Government with respect to this contract is **\$4,507,296.79**.”

2. Section 12, of the Statement of Work entitled: “Period of Performance” is revised to read as follows:

“The period of performance for this order is from September 29, 2006 through September 28, 2010. The term of this contract may be extended at the option of the government for one additional one-year option period.”
