Pursuant to 10 CFR 32.14, "Specific Domestic Licenses to Manufacture or Transfer Certain Items Containing Byproduct Material," the licensee is authorized to distribute electron tubes (lamps), and glow switches, containing not more than 30 microcuries of krypton-85, to persons exempt from licensing pursuant to 10 CFR 30.15, or equivalent provisions of the regulations of any Agreement State.
