ASSESSMENT

On June 3, 2010, the U.S. Nuclear Regulatory Commission (NRC) held a public meeting at the Fossil Ridge Public Library Meeting Room in Braidwood, Illinois. The meeting was between NRC Region III and Exelon Generation Company representatives to discuss the NRC's 2009 End-of-Cycle Assessment of Braidwood Station, Units 1 and 2, safety performance. The results of that assessment were discussed in a letter to the licensee dated March 3, 2010, which can be found in ADAMS at ML100610223.

The NRC began the meeting with an overview of the NRC and the nuclear industry, the NRC's Reactor Oversight Process (ROP) and national ROP results. This was followed by a summary of the NRC's 2009 assessment of safety performance for Braidwood Station, Units 1 and 2. The NRC's meeting presentation slides can be found in ADAMS at ML101590159 and the licensee's presentation slides can be found at ML101590147. Mr. Amir Shahkarami, Braidwood Site Vice President, provided an oral response to the NRC's assessment. In addition, Mr. Shahkarami discussed the licensee's view on the human performance substantive cross-cutting issue. Mr. Shahkarami also described some of the actions the licensee is taking to address this issue.
