Enclosed is Amendment No. 04 to your NRC Material License No. 24-26476-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please also note that we now require a total possession limit for the radionuclides listed on your license.

Within 30 days of the date of this letter, please submit, in writing, the total possession limit you wish to have for Subitem Nos. 8.A. through 8.F., inclusive. If you cannot respond within 30 days, please contact me at 630-829-9752 to make alternate arrangements. Please submit this information addressed to my attention, and refer to it as "additional information to control number 318858." We will then continue our review.

I already inserted a possession limit in new Subitem Nos. 8.E. and 8.F., since it appeared from your letter dated February 16, 2010, that you only wanted to become authorized for one gauge. If you wish to increase this authorization, please so state and define your possession limits in terms of maximum activity per source and total activity.

As a reminder, all documentation sent to the NRC must include the signature, title of the person providing the documentation along with the date submitted.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.

Pursuant to NRC's RIS 2005-31 and in accordance with 10 CFR 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.
